Objectives

General: Formulate proposals to strengthen and transform unionism in the Americas towards a new model of an inclusive organization of the diversity of the working class with the capacity for political, social, and economic disputes in the region.

Specific:

- **1.** Analyze the social and economic situation in the region and its impact on the union organization.
- 2. Identify the main critical nodes for union organization in the current world of work.
- **3.** Share the diagnosis on the level of representation of the current form of union organization in the Americas and its structural model.
- **4.** Prepare a ROADMAP towards the new model of union organization that we propose from the TUCA and that responds to the needs of the current working class.
